Montague Area Public Schools Request for Proposal Equip New Weight Room Facility

Montague Area Public Schools is accepting bid proposals to equip our new weight room facility in our new competition gym at Montague High School.

All proposals are to be submitted to MAPS Central Office, 4882 Stanton Blvd., Montague, MI, 49437.

All bidders must attend a pre-bid walk of the facility at Montague High School, 4900 Stanton Blvd., Montague, MI, 49437. Please contact Athletic Director Jay Mulder at 231-981-4537 or email mulderj@mapsk12.org to schedule an appointment. The bid will be discussed in detail during this pre-bid walk of the facility. Vendors will be asked to bring samples of some items. This will be discussed when the vendor schedules the appointment.

All proposals must be received by **1:00 p.m. on Wednesday, August 28, 2024**. All proposals must include a minimum of three references with contact information. Late entries will not be accepted.

Scope of the project

Install all new weight equipment in the Montague High School weight room. The proposed space is roughly 81' x 24'6". More exact dimensions can be obtained at the pre-bid walk of the facility. Work may commence after December 1, 2024, and must be completed by December 31, 2024.

No oral, telephone, E-Mail, telegraphic, or facsimile proposals will be accepted. No proposals will be accepted after the time of closing. The bid opening will take place at 1:00 p.m. on Wednesday, August 28, 2024 in the Montague High School Conference Room located at 4900 Stanton Blvd., Montague, Michigan.

All bids must meet or exceed all the specifications contained herein. Bids must be submitted on the attached form and be signed by the bidder. Bid documents to be returned:

- One signed copy of the bid form
- One signed copy of the Familial Disclosure Statement
- One signed copy confirming compliance with the Iran Economics Sanctions Act
- Mock layout of the proposed set-up of the weight room space
- Specifications associated with the items being presented in this bid

IRAN ECONOMIC SANCTIONS ACT

Michigan Public Act No. 517 of 2012

The undersigned, the owner or authorized officer of _____ (the “Bidder”), pursuant to the compliance certification requirement provided in the Montague Area Public Schools (the “School District”) Request for Proposals for the Equipping of the Weight Room at Montague High School (the “RFP”), hereby certifies, represents and warrants that the Bidder (including officers, directors and employees) is not an “Iran linked business” within the meaning of the Iran Economic Sanctions Act, Michigan Public Act No. 517 of 2012 (the “Act”), and that in the event Bidder is awarded a contract/purchase order as a result of the aforementioned RFP, the Bidder will not become an “Iran linked business” at any time during the course of performing the Work or any services under the contract.

The Bidder further acknowledges that any person who is found to have submitted a false certification is responsible for a civil penalty of not more than \$250,000.00 or 2 times the amount of the contract/purchase order or proposed contract for which false certification was made, whichever is greater, the cost of the School District’s investigation, and reasonable attorney fees, in addition to the fine. Moreover, any person who submitted a false certification shall be ineligible to bid on a request for proposal three (3) years from the date it is determined that the person has submitted the false certification.
